



## Cypress Communications Get Your VoIP On™ Promotion Complete Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN A PRIZE. A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING. Buying will not help you win. Beginning at 12:01 AM Eastern Time ("ET") on June 16, 2008 until 11:59 PM ET on September 16, 2008, you may enter the "Get Your VoIP On" (the "Promotion") by visiting the Get Your VoIP On Web site ([www.cypresscom.net/FreeVoIP](http://www.cypresscom.net/FreeVoIP)) (the "Web site") and completing the online entry form. Entrant must be a company to qualify. One entry per company (the "entrant") unless entrant provides a qualified lead referral which results in a sale of Cypress Communications C4 IP services during the promotion cycle. In the case of an entrant referral that results in a Cypress Communications signed contract for Cypress C4 IP service, the entrant may submit a second entry. Entrants must agree to and meet with a sales representative for a minimum of 30 (thirty) minutes to be entered in drawing.

**2. Eligibility:** This Promotion is open only to entrant company locations in the following metropolitan areas: Atlanta, Boston, Stamford, Tampa, Miami, Birmingham, Nashville, Washington DC, New York City, Chicago, Minneapolis, Indianapolis, Dallas, Houston, Phoenix, Los Angeles, San Diego, San Francisco, Seattle, Portland, Denver, Philadelphia, New Orleans, Orlando, Pittsburgh, Hartford. For the promotional free first 50 (fifty) seats, seat type will be defined based on a proportionate mix of your enterprise's contracted seat mix. Offer does not include any build-out, cabling and/or trenching required for the provision of the Services from the building's riser system to Customer's premises.
